

Gas transmission capacity offer of Magyar Gáz Tranzit Ltd. during the test period from 1st of April 2015 until 30th April 2015 (Gas Month)

We kindly inform you that, Magyar Gáz Tranzit Ltd. (hereinafter referred to as MGT) has published on its website (www.gaztranzit.hu) its monthly gas transmission test capacities available to book as of 1st April 2015 for one month for the Balassagyarmat SK>HU cross-border interconnection point, as an entry point and for the Balassagyarmat HU>SK cross-border interconnection point, as an exit point according to the following:

Offered interruptible monthly capacity at Balassagyarmat SK>HU cross-border interconnection point as entry point	163 200 000 MJ/day
Offered interruptible monthly capacity at Balassagyarmat HU>SK cross-border interconnection point as exit point	6 800 000 MJ/hour
Contract period (gas month)	From 1 st of April 2015 to 30 th of April 2015.
Type of transmission capacity	interruptible monthly capacity, interruption lasting longer than 25 gas days

MGT offers only interruptible transmission capacities during the test period from 1st of April 2015 to 30th of April 2015.

Tariff:

The transmission fees are calculated in accordance with the current MEKH Decree on gas network access fees, the rules of using incentives for improving service quality by the network operator by means of network access pricing, on applicable network fees depending on service quality, and on the conditions of applying network access fees, 1/2013.(VII.11.), Tariff Decree and its amendments.

Request and Allocation mechanism:

Requests shall be submitted not later than 10th of March 2015. midnight to MGT according to the following:

In case of overbooking MGT will allocate its above offered capacities to the requestors at pro-rata base. In case one requestor submit higher request than the above offered capacities MGT will curtail its request to the above offered level and allocate according to that.

Contract will be accepted from MGT in case Slovak Transmission System Operator: eustream a.s. will confirm equal contract on the Slovak side either by the System user or its Shipper pair. Contract will be binding in case of properly signed contract by MGT being delivered to system user.

According to 212/2014 Governmental Decree, no capacity booking is required at Vecsés connection point, but requestors must have KFSZRI contract with FGSZ for transition to the adjacent FGSZ system.

Bidders shall undertake to conclude a transmission contract with MGT and eustream in case of an accepted capacity request.

MGT shall require financial guarantee, which shall be the precondition for concluding the contract.

This capacity offer shall by no means be deemed as a contractual commitment of MGT towards any Bidder; and MGT explicitly reserves the right to declare the capacity booking procedure as unsuccessful within its own scope of competence. MGT has the right to offer daily interruptible capacities for testing the complete system capabilities. Shippers which has monthly interruptible capacities will has priority compare to daily interruptible capacities in case of interruption. MGT has the right for discontinuation of offering test capacities.
